

Chapter 1: Definition and Goals

Article 1: Definition

The Asia Savate Confederation that its abbreviations is A.S.C, in this Statute called Confederation, which is an independent, non-governmental and non-profit organization, that has financial self-sufficiency and is faraway all kinds of racial, religious, political tendencies, and has legal entity that according to charter of Olympic is as the greatest authorized authority of Savate Sport in Asian Continent is doing activities within the framework of this statute with the collaboration of the Federation Of International Savte (FIS).

Article 2: Goals

- 1- The permanent development and expansion of Savate's martial art in the Asian continent.
- 2- Establishment of organizational order in Asian Savate.
- 3- To support the benefits of the members.
- 4- To collect the necessary statutes and regulations, and assured of acquisition of performance of them.
- 5- To support the Olympic movement.
- 6- To cooperate with reliable International sports groups and associations.

Chapter 2: Obligations and the Fundamentals of Confederation

Article3: Obligations

- 1- Celebration of continent's championships in all different levels and different ages.
- 2- Celebration of different technical and academically courses, coaching, judges in different levels.
- 3- Establishment of regional federation and organizing federation in countries that Savate's activities are missing, and promotion of its quality in membered countries.
- 4- To develop policies, placing and execution of statues, articles and memorandum of association and the related guide direction.
- 5- Preparation and establishment of sport calendars concerning short time, mid time, and long time.
- 6- To select host country and city to celebrate Asian Championships, and different congresses.
- 7- To struggle with use of prohibited medicines and unauthorized illegal medicine among the Savate champions in Asian Continent.
- 8- To supervise activities and evaluations the functions of federations and associations of the membered countries and regional federations.
- 9- To publish educational instruction books, booklets and news of Continent's Savate.
- 10- Opposition with all kind uses of influences against the Olympic Prisms by the individuals, organizations and groups.
- 11- To avail the encourage fields, honor, appreciate and economical and spiritual supports from regional federation, membered federations and associations, sport men, champions, referees, coaches and other efficient authorities through granting facilities and related assistances.
- 12- Any activities that in some way are related to the goals and duties of the confederation.

Article 4: Foundations

- 1- General Assembly
- 2- President
- 3- Board of Directors

Article 5: General Assembly

- 1- The General Assembly which will called assembly from now on, is a meeting called conference that celebrate with the members of confederations assembly in determined periods.
- 2- The assembly sessions will organize in two forms of ordinary and extraordinary.
- 3- The president of assembly is responsible to run the session according to the instruction cases of session.
- 4- The location of the assembly's secretariant is in the confederation, and one of the confederation secretary as the secretary of the assembly will take part in the session without voting right.
- 5- Assembly has instruction, and all proposals must be passed to secretaryiant at least two months before of celebration of assembly.
- 6- The assembly celebrate ordinary at the end of each month of Christ era by the request of the president of confederation and the invitation of secretariant of assembly, and it has quorum with the attendances of at least two third of members. The resolutions of the assembly are valid according to the vote of half of present members plus one, and in lack of certain estate in the first session, after fifteen (15) days the assembly will celebrate and recognize officially with the attendances of the any number of members.
- 7- To celebrate extraordinary session of the assembly, will be according to the request of president of the assembly or president of the confederation, or at least two third of members of assembly after agreement of the president of the assembly.

Article 6: Members of Assembly

- 1- The president of Federation of International Savate (FIS) as president of the Assembly.
- 2- President of confederation.
- 3- Regional chairman of federations.
- 4- Chairmen of federations and associations of Savate in membered countries.
- 5- Members of the Board of Directors of confederation.

Note 1: Except the president of FIS, all members must have Asian Continent Countries Nationalities.

Note 2:In absence of president of FIS in assembly, the president of confederation will be responsible to rule over the assembly.

Article 7: Duties of the Assembly

- 1- To consider and approve the annual report of confederation.
- 2- To determine annual membership of membered countries.
- 3- To propose changes of the statute to the Board of Directors.
- 4- Choosing of president of confederation from members of assembly and giving propose to the Federation of International Savate (FIS) to issue the command.
- 5- To approve the shot time, mid time, and long time sport calendar of confederation.
- 6- To approve of assembly's internal articles of memorandum.
- 7- To verify related affairs to budgeting and expenses.
- 8- To nominate 3 persons as counters of votes (at time of elections)
- 9- Consideration on the submitted offers and plans.
- 10- To verify to the requests of members according to contents of this statute.

Article 8: president of confederation

- 1- The president of confederation will be chosen for four years and his reelection is unlimited and without encumbrance.
- 2- Except the first period of the presidentship (June 2008), that includes establishment, organizing confederation and starting the activities and the president of confederation will be appointed according to direct order of FIS president, in other periods, the point 4 of article 7 of this statue will be executed.
- 3- In case of death or acceptance of the resignation of the president of confederation by the FIS, immediately by the president of Federation of International Savate some one will be appointed as head of confederation. The Assembly is obligated to appoint the new president according to consideration of rules within maximum 3 months.

Article 9: Duties of the President of Confederation

- 1- Performance of the necessary effort to prepare the budget of confederation.
- 2- Supervising on careful performance of statutes of Savate in Asia Continent.
- 3- Signing of the awards of the champions, and the educational certificates of the supervisors, coaches, referees, and the athletes that take apart at the confederation`s educational classes.
- 4- Issuance of Directors commands for regional federations and membered federations and association also members of Board of Directors and Directors of Committees of Confederation.
- 5- Representative of confederation in organizations, authorities and courts of introducing of the official representative of confederation.
- 6- Extend or cancel of issued commanded orders, sign of administrative documents, financial, negotiable papers, agreements, administrative letters, memorandums, and statutes of the confederation.

Article10: Board of Directors

- 1- The Confederation's Board of Directors' members are as fallow:
 - A- President
 - B- A Vice president or Vice presidents
 - C- G.Secretary or secretaries
 - D- A Treasurer
 - E- Four other persons with inform of Federation

International Savate

- **Note 1:** In case of need and distinguish of the confederation's president, maximum 5 vice presidents and 5 other secretaries will be busy to work in confederation.
- **Note 2:** Vice presidents and secretaries are responsible to perform all execution affairs of confederation according to confirmation of president of confederation. The complete description of duties of vice president and secretaries will be determined in the related memorandum.
- 2- Board of Directors' sessions will recognize officially with attendances of at least two third of the members.
- 3- The decisions of Board of Directors will be made at least with half + one of present members. In case of equality of the votes, the vote of president will determine the result of the subject of the negotiation.
- 4- The obtained decisions will be recorded in the proceeding.
- 5- The made decisions by the Board of Directors must executed in maximum 48 hours, unless the Board of Director makes any other decision.

Article 11: The Duties of the Board of Directors

- 1- Preparation and collection of the annual function of the confederation and presentation of it at the assembly.
- 2- Plan and approval of budget and presentation of short time, mid time and long time calendars of the confederation to Assembly.
- 3- Consideration of presented offers for plan in assembly.
- 4- Approval of the statutes, concerning all administrative, execution, employment, financial and articles of memorandum and other needed rules and regulations of confederation.
- 5- Approval of statute of regional federations and membered countries.
- 6- Approval and confirmation of authorities are engaged for election of the confederation presidency according to the related rules.
- 7- Supervising and consideration of functions of membered countries and applying of related rules.

Chapter 3: Other Rules

Aticle 12: Budget

The budget of confederation is provided through following sources.

- 1- Financial help of the Federation of International Savate (FIS).
- 2- Financial help of reliable sport organizations such as Asian Olympic consolation, International Olympic committee without influence of the Confederation.
- 3- Financial help of actual individuals and all those sport interested.
- 4- Membership of federations and membered countries.
- 5- Obtained incomes from sport salary such as television broadcast and commercial advertisements.
- 6- Obtained incomes from sells of games tickets, sport and education programs.
- 7- Collection of loan from the financial credit institutions and reliable banks.

CONFEDERATION Article 13: Committees

1-Confederation includes the following constant committees.

Technical committee, Competitions committee, Referees committee, Coaching Committee, Educational committee, Executive committee, Medical committee, Disciplinary committee, Inspection Committee, Legality Committee, Cultural Committee, Development & Research committee, General and International Affairs Committee and Related Statistics, Members Performance Evaluation committee, Marketing and Development committee, Financial and Budget Committee, Finding talent committee, Programming Committee and Coordination committees, General Relations Committee, Advertising Committee, Unti Doping Committee and Students Committee.

2- The temporary confederation committees will establish in case of need by the Board of Direct in limited time. 3- Duties and method of activities of committees are compiled and defined in reason to concerning the permanent and temporary special regulations established by the Board of Directors.

Article 14: Headquarter Office

1-All office affairs, communications and also keeping and saving of the records and documents, draw up the proceedings of Board of Directors, committees and coordinating of all confederation's affairs all be performed at the headquarter office. Headquarter office of confederation is located in Tehran.

Article 15: News of confederation

1-The news and events related to confederation through the Internet base with address www.Asiasavate.ir will be in authority of sport man, membered countries, fellow members and all those interested in around the world.

Any changes in address and related affairs, after approval of the Board of Directors will be announced to public.

Article 16: Places of Arbitration

1- The disputes related to members of confederation, regional federation and membered countries will be considered in the legality committee of the confederation.

The legality committee is responsible to carefully, deliberate the related complains, and then issues the necessary orders according to the regulations.

2- Confederation can nominate the International court of arbitration in sport (CAS) in Lozan city of Switzerland in case of necessities to save the rights of organizations and sport man under the care of it, with consideration to related statutes, to investigate and settle the cases.

Article 17: Formal Languages

1-The formal language of confederation is English and Persian. The priority in all texts and communications will be in English language.

Article 18: Undertaking of members

1-All regional confederation, Savate's establishments of membered countries, actual and legal individuals of confederation are responsible to observe the articles of this statute, following of laws and rules, recipes, decisions and also the confederation morals standards.

Article 19: Impartiality and lack of Prejudice

- 1- Confederation will not interfere into the political and religious affairs of Federations, Associations and Members.
- 2- None of the federations can take any prejudice action toward individuals, groups, nationalities in matter of sexes, language, religion, race and politic or other similar matters. Otherwise they will be suspended or eliminated.

Article 20: Representation and right of Signature

- 1- All Administrative Communications, Documents, Guide Directions, Negotiable Papers and Memorandum of Association will be valid with signature of the president of confederation on it.
- 2- President of Confederation can vest some of his authorities to the first vice president.

Article 21: Execution of the Statue

1-This Statute is prepared and approved in 3 chapter, 21 articles, 84 Points and 4 notes, by the Statutes collection committee of the Asia Savate Confederation in July 24, 2008, and August , 2008, with registered no -confirmed by Federation of International Savate (FIS) and is indispensable.
